

## **2016 CLUB MEMBERSHIP SWEEPSTAKES RULES**

**(1) SWEEPSTAKES PERIOD:** The Sweepstakes begins at 12:01am Pacific Time on Aug 1, 2016 (the "Sweepstakes Start Date") and closes at 6 pm Pacific Time on Oct 7, 2016 (the "Sweepstakes End Date" such period being the "Sweepstakes Period"). Participation in the Sweepstakes constitutes full and unconditional agreement and acceptance of these Sweepstakes Rules, which are final on all matters relating to the Sweepstakes.

**(2) HOW TO ENTER:** Entry can be made in three (3) ways:

- a. New members may enter by completing a Club Membership Application at one of the following locations: Delta Breeze Club Cashier Cage (Tuesday-Friday 11am-3pm), Travis Bowl (Mon-Sun 11am-8pm) or at any Full Access Marketing "Street Team Event" (schedule will be posted at TravisFSS.com). Application can be found at all of the prelisted locations. Completed applications can be given to one of the cashiers or customer service staff. Online entries will not be eligible for the sweepstakes.
- b. Current Club Members may enter by referring new members. To do so, current members must escort their referral to the Delta Breeze Club Cashier Cage (Tuesday-Friday 11am-3pm) and present their club membership card to the cashier or staff member. One (1) entry is allowed per referral.
- c. *"NO PURCHASE NECESSARY"*. Those entries without a Club Member Application may only enter at the Delta Breeze Club Cashier Cage (Tuesday-Friday 11am-3pm).

**(3) WHO CAN PLAY:** Sweepstakes open to all United States Air Force military members, DOD civilians, retirees and NAF civilians who are 18 years of age or older at time of entry, except employees and immediate families (siblings and children) of Travis 60<sup>th</sup> Force Support Full Access Marketing Department, and each of their respective spouses, parents, additional family members or affiliates.

**(4) WINNER SELECTION:** Winners will be selected in a random drawing on or about Oct 7, 2016 from among all complete, eligible entries received.
